Westminster Oaks New Memory Care Building Hosts Ribbon-Cutting and Blessing of the Building

On October 13, 2021, the new Memory Care neighborhood at Westminster Oaks hosted its ceremonial ribbon-cutting and "Blessing of the Building" prayer from the Rev. Taylor Phillips, the community's chaplain. This new neighborhood at Westminster Oaks, a Life Plan Community in Tallahassee, features 32 apartments for Assisted Living residents with Alzheimer's and dementia with dedicated, specialized amenities and spaces to support these residents.

Westminster Oaks and Westminster Communities of Florida are delighted to welcome this newest addition to the community. "This is one of the most exciting ways in which our community has expanded, because we are doing something completely different and innovative," says Westminster Oaks Executive Director Shannon Sauls. "It's a very exciting time to be here at Westminster Oaks."

The Memory Care center, costing more than \$9 million, was designed as a set of small, secure neighborhoods with spacious private apartments, a memory garden and more. In addition, it features innovative and sustainable building features, like higher-efficiency HVAC systems, zero VOC paints and sealants, and long life-span construction materials, and it was constructed to the National Green Building Standard Silver level. Residents began moving into their new residences in January.



Linda Shelley, representing Westminster Communities of Florida's Board of Directors, says, "There aren't any of us who don't know someone who has needed support like this, or has a close friend, or someone we know. Until the time comes when memory care isn't necessary, it is important to all of us that our residents and loved ones have a safe and beautiful place to be, and to enjoy their lives. Thank you, on behalf of the Board."

Year-End Campaign Focus on Rental Retirement Communities

If the 2021 year-end giving campaign was any indication, donors to the Westminster Communities Foundation are welcoming the chance to expand opportunities at Westminster's 12 Rental Retirement Communities (RRCs).

When it was all said and done, giving to the Mission Preservation Fund totaled just over \$70,000 over the final months of the year, far surpassing the two previous giving years combined and providing a much-needed boost to programming and services for these residents.

The low-income opportunities at RRCs are increasingly valuable in areas of Florida that have experienced real estate booms, providing stability where seniors might have otherwise been forced to move or relocate.

Giving Back to the Fund

So It's There When Others Need Our Help

When someone gives to the Westminster's Benevolent Assistance Fund, it often comes from heartfelt empathy. For Dawn Murphy, the empathy comes from direct experience.

Dawn's mother first came to Westminster Point Pleasant as an independent resident, and from the very beginning, the Westminster Communities Foundation made a difference through an Honorable Service Grant in recognition of her mother's many years as a church worker. Even with the grant, however, it was clear from the beginning that her savings might not last. Even though she had a good long-term care insurance policy, she was still an independent resident when she ran out of resources and needed to apply for benevolence.

Thankfully, as Dawn discovered, starting benevolence wasn't an unsettling process.

"I was so appreciative that attention was paid [by administrators] to keeping Mom's quality of life up—not just scraping by," Dawn says. "They wanted Mom to be taken care of well."

Dawn's experience with Westminster goes back two generations to her grandmother, who lived the last three years of her life in Point Pleasant's health center. Dawn spent those years advocating and also volunteering.

"Scripture teaches that children have a responsibility to give back to their parents to bless them for how they have cared for them. I just prayed for God to give her good days at the end and He honored that desire," says Dawn, adding that many of the staff became like family to her.

When her mother was widowed about six years later, Dawn, along with her sister Nikki Wiktorsson, had to make some hard decisions as her mother also declined in health. That eventually put her back on the road to working with Westminster, where her mother lived independently for

nearly three years before moving into assisted living there. Although she had been on Benevolent Assistance for most of her final year as an independent resident, Dawn's mother has a long-term care insurance policy that now helps pay for her rent and care.

Rather than moving on after her mother's needs were now paid for, Dawn and Nikki decided to spend a year tithing back to the Benevolent Assistance Fund at Point Pleasant in gratitude for the help they received while bridging the critical gap between living alone and eventual assisted living.

"I'm so very grateful God provided through the Benevolent Assistance Fund when my mom needed it, and now she is able to give back." Dawn said at the time of the family's first gift, "The staff told me it wasn't necessary, which speaks loudly to the heart of the organization."

Since 1974, benevolence at Westminster Communities of Florida has been 100 percent donor-funded through the Westminster Communities Foundation. To give a tax-deductible gift or to consider the Foundation in your estate, reach out to the Foundation office at your local Life Plan Community.

"We appreciate the friendly and accepting attitude of the residents and staff," they share. "The location is superior, and the facility is top-notch. You couldn't ask for more."


That's in part why they've chosen to give back to the community they love so much.










An Organizer for Important Estate Planning Information

Where to Look First

Provide your family and loved ones with a one-stop guide that can help identify and locate all your important documents when it comes time to settle your affairs. Once you have completed this guide, give a copy to your executor and attorney, keep the original with your other important papers and update it at least every two to three years. If you are married, have your spouse complete a separate guide.



Power of Attorney

With a power of attorney, you allow someone to act on your behalf in the event that you are unable to do so yourself. For example, you could be on an extended vacation or affected by a temporary medical condition. The power of attorney allows the holder of the power to transact business, including buying, selling and gathering assets; discharging debts; and handling real estate.

A health care power of attorney allows you to appoint someone to make medical decisions on your behalf should you become unable to do so.
